OF THE 13 HIGH-INTENSITY AREAS IDENTIFIED IN THE UNITED STATES BY THE FEDERAL BUREAU OF INVESTIGATION FOR CHILD SEX TRAFFICKING, THREE ARE LOCATED IN CALIFORNIA: LOS ANGELES, SAN FRANCISCO, AND SAN DIEGO METROPOLITAN AREAS. ZOE HOME FOR YOUTH (ZHY) PROVIDES SPECIALIZED, INTENSIVE TREATMENT AND 24-HOUR CARE AND SUPERVISION FOR UP TO 6 YOUTH, AGES 12-17, WHO HAVE EXPERIENCED COMMERCIAL SEXUAL EXPLOITATION AND OTHER SLAVE-LIKE TREATMENT. WE ARE SO THANKFUL FOR OUR AMAZING PARTNERS WHO PROVIDE OPPORTUNITIES AND EXPERIENCES FOR THE CHILDREN WE SERVE.
